Urgent Drug Recall

Dear Valued Customer:

Mylan Pharmaceuticals, Inc. is conducting a voluntary recall of Ciprofloxacin Tablets manufactured utilizing Active Pharmaceutical Ingredient (API) supplied by Smruthi Organics Ltd., a third party raw material manufacturer. Based on close collaboration with FDA, these products are being recalled due to GMP compliance issues identified at Smruthi's manufacturing facility. Affected lots were distributed between June 30th, 2011 and December 25th, 2012.
